NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

CLAUSE 3

INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, by express grant, implication, Estoppels or otherwise, create in either party any right, little, interest, or license in or to the intellectual property (including but not limit to know-how, inventions ,patents, copy rights and designs) of the other party.

CLAUSE 4

VALIDITY

4.1 This agreement will be valid for a period of 3 (Three) years or until it is expressly terminated by either party on mutual agreed terms whichever is earlier during which period, HERO SHOW ROOM, Nabarangpur, the second party, as the case may be, will take effective steps for implementations of this MoU. Any act on the part of HERO SHOW ROOM ,Nabarangpur, the second party after termination of this agreement by way of communication, correspondence etc shall not be constructed as an extension of this MoU.

Both parties may terminate this MOU upon 30 calendar days' notice in written. In theevent of ^{termination}, both parties have to discharge their obligations.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **Government Polytechnic**, **Nabarangpur** and **Hero SHOWROOM.Nabarangpur** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
