(First Party and second party are herein after jointly referred to as "Parties" and individually as "partiy")as

WHREAS:

- A. First party is a higher educational institution named;
 - (i) Government Polytechnic, Nabarangapur
- B. First party and a second party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- C. The parities intent to cooperate and focused their efforts on cooperation within area of Skill Based Training Education Research.
- D. Both parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.
- E. Ex Engineer TPSODL, Nabarangpur- The second party is engaged in Business manufacturing Skill development, Education and R&B services in the field's name of trade and services underthe Industry concerned —and related fields.
- F. Ex Engineer, TPSODL Nabarangapur the second party is a promoted by promoter name Group; Address and background of the company.
- G. Give related information, its branches, and dimensional information about the industry concerned with whom the MoU is sworn.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU,THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO- OPERATION

- 1.1 Both parties are united by common interest and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings.
- 1.2 First party and second party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of first party providing significant inputs to them in developing suitable teaching /training systems, keeping in mind the needs of the industry, the second Party.
- 1.3 The general terms of co-operation shall be government by this MOU. The parties shall cooperate with each their and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents) as may be required to give effect to the action contemplated in terms of this MOU. The term of Definitive Documents, this MOU shall be mutually decided between the parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MoU

- 2.1 The budding graduate from the institutions could play key role in technological up-gradation, innovation and competitiveness of an industry, both parties believe that close co-operation between the two would be of major benefits to the student community to enhance their skill and knowledge.
- 2.2 Curriculum Design: Second party will give valuable inputs to the first party of teaching/ training method and suitable customize the curriculum so that the students fit into the industrial scenario meaningfully.
- Industrial Training & Visits: Industry band Institution interaction will give an insight in to the latest developments / requirements of the industrial training Second party to permit the Faculty and Students of the First party to visit its group companies and also involve in industrial Training Program for the party. The industrial training and exposure provide to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party was provide its Labs/Workshops/Industrial site for the hands—on training of the learners enrolled with the first party.

- Research and Development: Both parties have agreed to carry out the joint research activities in the Manufacturing, Operation Maintenance.
- Skill Development Programs: Second party to train the students of first party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.6 Guest Lecturers: Second party to extend the necessary support to deliver—guest lecturer to the students of the first party on the technology trends and in house requirements.
- 2.7 Faculty Development Programs: Second party to train the faculties of first party for imparting training as per the industrial requirement consideration the National Occupational Standard in concerned sector, if available.
- 2.8 Placement of Trained Students: Second party will actively engaged to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements.
- 2.9 Both parties to obtain all internal approvals, consents, permission and licenses of whatsoever nature required for offering the programs on the terms specified herein.
- 2.10 There is no financial commitment on the part of the Govt.Polytechnic, Nabarangapur the first party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, by express grant, implication, Estoppels or otherwise, create in either party any right, little, interest, or license in or to the intellectual property (including but not limit to know-how, inventions ,patents, copy rights and designs) of the other party.

CLAUSE 4 VALIDITY

This agreement will be valid for a period of 3 (Three) years or until it is expressly terminated by either party on mutual agreed terms whichever is earlier during which period, T.P.S.O.D.L. Nabarangpur the second party, as the case may be, will take effective steps for implementations of this MoU. Any act on the part of T.P.S.O.D.L, Nabarangapur ,the second party after termination of this agreement by way of communication, correspondence etc shall not be constructed as an extension of this MoU.

Both parties may terminate this MOU upon 30 calendar days' notice in written. In the Parties have to discharge their obligations.

RELATIONSHIP BETWEEN THE PARTIES

TPSUDL

5.1. It is expressly agreed that Government Polytechnic, Nabarangpur and Southco utility, Nabarangpur are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representation or create any obligation or liability, expressed or implied, on behalf of the other party, without the other prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
